Worlds Imploding: Politics and Security in the Gulf and the Middle East

Today's Middle East is embroiled in several civil wars that have destroyed the fabric of four regional states—with the wreckage littering the landscape like shattered glass. The region remains in the grip of dangerous interstate rivalries, manifesting themselves in the proxy wars that show no signs of ending. In the Gulf, Saudi Arabia and Iran continue their war of words and some suggest that war between these regional heavyweights is a possibility.

Professor James Russell, associate professor of national security at the Naval Postgraduate School's Department of National Security, will share his perspectives on the region's implosion and the challenges this creates for U.S. strategy and foreign policy. The views presented at the luncheon are his own.

Professor Russell teaches courses at NPS in his department's Middle East studies curriculum.



He also teaches courses in strategy and military innovation. He has authored numerous articles and blogs occasionally at the lobe.log at https://lobelog.com/author/james-russell/.

His latest book is *Maritime Strategy* and Global Order, Ed., with Daniel Moran (Georgetown University Press, 2016). He is currently working on a book that examines the long term impact of climate change on the stability of the Middle East.

Professor Russell earned his PhD in war studies from King's College, the University of London in 2009. He has been teaching at NPS since 2001. Prior to arriving at NPS, he worked for 15 years as a civilian in the Office of the Assistant Secretary of Defense for International Security Affairs (Near East and South Asia).

Crisis in the European Union

Presentation by Dr. Michel R. Gueldry, Middlebury Institute of International Studies November 29, 2017 By Edwin P. "Phil" Morgan

Gueldry identified a number of political and social tensions in several countries of Europe threatening the future unity and democratic character of the EU.

- The United Kingdom: The Brexit decision reflects long-held suspicions of formal ties to Europe, of immigration, and an intra-UK north-south divide symbolized by London's affluence and cosmopolitanism compared to the slowdown in the mid-and northern industrial centers.
- France: In the fall presidential elections, the anti-EU, anti-immigration populism of Le Pen's right-wing did not prevail. However, anti-NATO and anti-Eurozone forces and labor unions on the left also challenge the "minority" Macron government.
- Germany: In September, the center-right party of the seemingly invincible Chancellor Angela Merkel suffered a reduced majority in the federal legislature, forcing her to look for a workable coalition with other parties. Merkel has been unsuccessful to date. A populist right-wing party also emerged with 15 seats, propelled mostly by antiimmigration rhetoric, which means that debates in the Bundestag will now include language not heard since 1945.
- Poland and Hungary: In both countries immigration of non-Europeans has essentially ceased, nationalist rhetoric and anti-Semitic insults of outspoken liberals has emerged. Recent legal measures have been taken to undermine the independence of the judiciary and the public media, most clearly in Poland.

The spirit of the EU project has always been to foster prosperity through cooperation as a means to preserve peace in Europe. Liberal democracy and multilateral approaches to decision making have been crucial to that success whether in the areas of trade and economic cooperation, mutual security and the deepening of democratic institutions.

In Memoriam

Abby Foss

Abby Foss, who served the World Affairs Council, Monterey Bay, as secretary and Passport editor for many years, died Nov. 30 at her home in Monterey of heart failure.

She was well known on the Monterey Peninsula as a horse trainer, stable manager and master of foxhounds.

Born Abigail Langdon Wilder Sept. 24, 1928, in Newark, N.J., she had lived on the Peninsula since 1975.

Abby graduated from UCLA where, in her senior year, she was managing editor of the university's Daily Bruin newspaper.

She then worked as a buyer for a large department store, where she met her husband, Jay Foss. The two lived in Houston, Texas, Albuquerque, N.M., and Atlanta, Georgia, before moving to the Peninsula.

Abby was a founder of the Juan Tomas Hounds fox hunting club in Albuquerque and co-master of the Los Altos Hounds in San Benito County.

She managed the Pebble Beach Equestrian Center, Cypress Stables in Monterey and Holman Ranch stables in Carmel Valley.

Abby was preceded in death by her husband, a sister, Jane, and two sons, Robert and Langdon Foss. She is survived by a niece, Margot Jacqz of New York and a nephew, Christian Jacqz of Ipswich, Mass.

A celebration of her life will be held 2:30 to 4:30 p.m. Saturday, Jan. 13, at Carmel Valley Manor. There is no parking at the Manor. Please park at the Sanctuary Bible Church, 8340 Carmel Valley Road, just east of Schulte Road, on the south side of Carmel Valley Road. A shuttle bus will take you to the Manor.

These challenges not only undermine progress toward an integrated Europe, they have parallels in American populism, openly expressed racial and religious prejudice, policies which aggravate inequality, and pander to plutocrats which, together, contribute to what Gueldry called a "Disunited States".
